1. Phase One Programme and Overview

The Recovery to Development Plan was approved on 23 October 2018 and published on 10 November 2018. The plan can be downloaded here. From November onwards, the RDA will be working on an implementation schedule with the Government, in accordance with Government priorities, to prepare business cases for longer-term transformative projects.

As of now, the RDA is working on the delivery of the Phase One Programme (also referred to

The RDA Business Case process is a robust evidencebased mechanism to assure value for money with five cases examined:

- Strategic case how project benefits will deliver intended change
- Economic case costs and benefits of the project
- Commercial case project delivery strategy
- Financial case affordability of proposed project
- Management case how project will be delivered

as the 6-month Accelerator Plan). This Programme contains high priority projects that have immediate impact to kick-start the economy, support vulnerable households, re-establish key public services, and prepare the Virgin Islands to be tourist-ready.

The Cabinet identified the priorities for the Phase One Programme in the Accelerator Plan approved by Cabinet in July 2018. The RDA then worked with the ministries, relevant departments, and statutory bodies to refine these priorities to reflect work already underway by the Government and any minor shift in priorities since July 2018. The final list of projects for the Phase One Programme was then formally signed-off with each ministry by the Permanent Secretary, with the concurrence of their respective minister. This process was the basis for the design of the Phase One Programme, which is detailed in this Business Case.¹

Currently there are six projects ongoing in the Phase One Programme as of 30 November:

1.2. Capacity Building

In accordance with the draft regulation on capacity building, the RDA will work in partnership with the Government to develop and finalise a Capacity Building Strategy. This strategy will detail how the RDA will mainstream capacity building as an integral element of everything that it does, to maximise BVI participation and leadership of the recovery and to ensure maximum benefit for BVI individuals, communities, and companies.

The RDA has to-date focused on building capacity of contractors and suppliers, particularly in how to put together good quality tender submissions. In preparation for the Special Debris Clearance Project, the RDA held bidder briefing sessions on Tortola, Anegada, and Virgin Gorda. The sessions explained the RDA procurement procedures and how suppliers can compete for work under this project as well as a brief on future project opportunities. The tender submission format for this project was also deliberately made very simple with an established template that was easy to complete. This encouraged 29 contractors to submit bids for this project.

For the more complex projects of repairs to the Virgin Gorda Police Barracks and the Jost Van Dyke administration building, a simple tender submission was not feasible due to the complexity of the required repairs. Therefore, the RDA has undertaken detailed site briefings for all interested contractors and then provided detailed feedback and requests for clarifications to support all bidders equally to assist them in the submission of fully compliant bids.

1.3. Risk

A central component of delivering programmes is to analyse and manage risks, including the time, quality, and cost of individual projects. The table below maps out some of the high-level risks that the RDA has identified and is actively managing to ensure the success of the RDA and the delivery of the programme.

1.4. Research, Monitoring, Evaluation and Learning

The RDA has commenced work on developing the monitoring framework for the delivery of the Recovery to Development Plan and is developing the detailed monitoring plan for the Phase One Programme. As of **November**, the RDA has continued to develop this frame by clarifying outcome statements and the RDP's vision. Further updates will be provided in the **December** Monthly Report.

2. Planning Implementation

This section pertains to progress that programs or projects have reached before the signing an agreed upon Statement of Requirement (SoR) in Phase One.

2.1. Future Planning

While Phase One is already in the implementation phases, the RDA is working on more long-term development projects across the Virgin Islands.

2.1.1. West End Area Programme

The West End ferry Terminal has been a node for travellers moving to and from the US Virgin Islands, for medical, shopping and leisure activities ('day trippers') as well as 10,000 or more private and charter yachts per year. The destruction of the facility during hurricanes Irma and Maria has presented challenges to travellers wishing to travel to the BVI for leisure and has resulted in the additional utilization of the Road Town Ferry Terminal, which has presented a capacity problem in that terminal.

This month, the RDA with the Immigration Office, Ministry of Communications and Works on behalf of the Port Authority and Customs for the development of the Statement of Requirement (SoR).

2.1.2. Renewable Energy

The Renewable Energy (RE) regulation to provide the opportunity for gird tied systems was published by the Government of the Virgin Islands on the 1st November 2018. This has provided the environment for a strategic review of the power infrastructure network.

The Recovery and Development Agency in partnership with the BVI-EC have established a Renewable Working Group that will focus on building back a more resilient and sustainable electricity infrastructure. The working group will provide the strategic plan for the rebuild with growing reliance on renewable energy in the BVI energy sector.

As of **November**, the RDA has hired a strategy adviser for renewable energy development. The outcome of this appointment will be to build and implement the strategy for the BVI renewable sector. A key to this will be the need to build strategic relationships with critical stakeholders ultimately leading to a sustainable energy strategy for the BVI.

3. Relevant Policy

The RDA's implementation of projects and initiatives inextricably requires that relevant laws, regulations, and policies relative to sectors and sub-sectors supports their delivery. To this end, the Government has committed to ensuring that an enabling legal and policy environment exists to ensure efficient implementation of the projects and initiatives the RDP sets out. The following legal or policy development have taken place or is required to be put in place to further the delivery of the projects:

5. Project Updates

Project updates pertain to projects which have a signed and agreed upon SoR (Statement of Requirement). Currently we have 6 projects underway. Currently, all six priority projects are listed under project updates regardless of their status.

6. Project Update: Special Debris Clearance

Project: 108

Status: Almost Complete

Budget: \$647,000

Outcome 1: Improved tourism product that is aesthetically appealing, easily accessible and provides an enhanced experience to our visitors and a catalyst for economic recovery

6.1. Overview

The hurricane disasters resulted in a significant amount of debris being deposited across the Virgin Islands and the project was developed to support the Department of Waste Management (DWM) to collect the debris. The objective of this project was to reduce the risk of damage and threat to human life, by removing debris which could become projectiles during strong winds ahead of the height of the 2018 hurricane season (early September).

6.2.Status

August 2018: Work packages in Tortola, Anegada, and Jost Van Dyke were commenced.

September 2018: Work packages in all areas except Virgin Gorda were completed in early September. The collection of derelict vehicles and removal of waste from the waste site in Virgin Gorda has been delayed. The work will commence once the car crusher and barge arrive and will likely take place in late November and early December.

November 2018: Still awaiting crusher and barge for moving derelict vehicles & scrap metal, which is due to arrive in BVI on 1 December. The contractors have signed a PMI to date extension of the works already agreed.







7. Project Update: Removal of Derelict Boats

Project: 133 Status: Planning

Outcome 1: Improved tourism product that is aesthetically appealing, easily accessible and provides an enhanced experience to our visitors and a catalyst for economic recovery

7.1. Overview

The passing of hurricanes Irma and Maria in 2017 left a significant number of marine vessels stranded along the coastlines and bays of the Virgin Islands. The bulk of these vessels have been removed by the owners and their insurance providers. However approximately 200 derelict vessels remain that need to be removed from their land or sea location and then disposed of.

7.2. Status

October 2018: Planning had commenced and was at the 'Statement of Requirement' phase with an agreement that was reached with relevant stakeholders on the most effective option to remove boats to a staging area. A decision on the final disposal method was pending further research on the available options.

November 2018: The RDA set up both working group and stake holder meetings to be conducted in early December.







8. Project Update: Elmore Stoutt High School

Project: 147 Status: Planning

Outcome 2A: Restored educational and recreational facilities that provide a safe and secure environment for learning and recreational activities

8.1. Overview

The RDA is overseeing construction of temporary classrooms for Elmore Stoutt High School in consultations with the ministry and landowners. The outcome of the project is to improve the present conditions at the school.

8.2. Status

October 2018: Planning has commenced at the 'Statement of Requirement' phase. In October there was an initial site visit and meeting with the ESHS and ESHS teachers.

November 2018: Statement of Requirement meeting held with the school. A draft SOR was sent to the school for approval and currently awaiting feedback. SOR to be sent to Assistant PS for approval after review and agreement. Then detailed planning of all aspects of the refurbishment can begin.







9. Project Update: AO Shirley Grounds

Project: 162 Status: Procurement

Outcome 2A: Restored educational and recreational facilities that provide a safe and secure environment for learning and recreational activities

9.1. Overview

The AO Shirley athletics grounds is a priority project to renovate the grounds to meet international accreditation standards as a Level 2 ground, so that BVI can host upcoming national events in the new year and future international events. This will require preparation of the grounds prior to the installation of the new track by the specialist company Mondo, repairs to make the perimeter secure to boost income-generation from events, installation of bathroom facilities, installation of lights to allow events after dark, repair to the spectator stand (ideally with shade), and renovation of the clubhouse pavilion to provide meetings, events and changing facilities.

9.2. Status

October 2018: Planning is complete for Phase 1 (rebuilding parts of damaged wall) and the works are now being procured.

November 2018: Containers with materials for the track were transported to site this month. Currently awaiting arrival of MONDO technician to commence the works in mid-December. The frame and panels for the perimeter wall is being procured. Tenders have been received for the bathroom and are being reviewed to ensure value-for-money.





10. Project Update: Virgin Gorda Police Barracks

Project: 182 Status: Procurement

3B: Functioning law enforcement institutions communication networks to restore a sense of safety and security and

improved communications between agencies

10.1. Overview

Outcome

The purpose is to return the Virgin Gorda Police Barracks to a fully functional state with police able to deploy required numbers from Tortola. A key outcome will be for the police to be able to sleep personnel on Virgin Gorda to ensure a shift system can be effectively managed and to enable the pre-disposition of resources key to disaster preparedness ahead of the 2019 hurricane season.

10.2.Status

October 2018: Planning is complete, procurement is underway, and work is anticipated to begin at the end of November.

November 2018: A contract was signed on 21 November and work has started.

Budget: \$800,000





11. Project Update: Jost Van Dyke Admin Building

Project: 183 Status: Procurement

Outcome 3C: Immediate improvement to priority government infrastructure and systems to improve services key to easing ability of doing business and prepare for recovery

11.1. Overview


The repairs to the Jost Van Dyke administration building will re-establish a working space for the District Officer to coordinate public service delivery on the island, as well as space for the police, customs and immigration to become fully functional. This will re-establish a fully functioning border control point at the main jetty and re-establish a functional police base, including a cell. The full detailed scoping for this project has been completed and procurement has already commenced.

11.2.Status

November 2018: Planning is complete, procurement is underway, and pending completion of procurement process, works anticipated to start by end of November. There was a meeting pre-start coordination meeting with the District Officer, Police Commissioner, Immigration, Customs and the Office of the Governor, which resulted in an updated Statement of Requirement to improve flow of the project. Finalization of contract negotiations to begin in December.



Recovery and Development Agency: DRAFT Phase 1 Timeline




