# 1.1. Future Planning

While Phase One is already in the implementation phase, the RDA is working in parallel on the planning of other recovery and development projects across the Virgin Islands.

#### 1.1.1. West End Area Programme

The West End Ferry Terminal has been a node for travellers moving to and from the US Virgin Islands, for medical, shopping and leisure activities ('day trippers') as well as 10,000 or more private and charter yachts per year. The destruction of the facility and damage to the surrounding area during hurricanes Irma and Maria have presented challenges to travellers wishing to travel to the BVI for leisure and has resulted in the additional utilization of the Road Town Ferry Terminal, which has presented a capacity problem in that terminal and detrimental economic impacts on the West End.

In close consultation with stakeholders the RDA has completed an initial Statement of Requirement for the West End Ferry terminal. This SOR was presented to the agents of a potential benefactor in the design and buildout of the said facility. A response on a design proposal in addition to a proposal on the level of contribution that this investor is proposing, is expected by the end of February 2019.

#### 1.1.2. Renewable Energy

The Government of the Virgin Islands published the Renewable Energy (RE) regulation on the 1st November 2018. This has provided the enabling environment for a strategic review of the power infrastructure

network. Formal meetings of the working group have continued into January. Currently, the RE expert is developing the long-term strategy for transformative energy change.

In January the RDA facilitated a second BVI Energy Plan Working Group session along with the BVIEC, Ministry of Natural Resources and Labour and Ministry of Communication and Works. Jointly, we defined a draft Terms of Reference for the group, with the remit to create a strategy paper and Energy Plan outline that we can deliver to the new Government in March.

The strategy advisor created a financial model and deployment schedule using market data points for renewable costs, that show the potential to half the cost of electricity in the Territory, while creating substantial improvements to resilience, through the deployment of distributed solar and storage assets, where they are delivered in combination with the grid resiliency work currently planned. The RDA's goal is to support the work of the BVIEC to complete the strategy paper and energy plan and deliver a comprehensive strategy the new government can approve.

# 2. Relevant Policy

The RDA's implementation of projects and initiatives requires that relevant laws, regulations, and policies support their delivery.

On 14 January 2019, the RDA received the Letter of Expectations from Government on priorities. During the month of January, the RDA also hosted workshops with Ministries to agree on results for the implementation schedule and priorities. The Board will formally respond to the Government's Letter of Expectations when this exercise is complete.

# Virgin Gorda Baths

# Lead ministry: Natural Resources and Labour

# Project: 103

# Status: Planning

Outcome 1: Improved tourism product that is aesthetically appealing, easily accessible and provides an enhanced experience to our visitors and a catalyst for economic recovery.

### Overview

The Baths at Virgin Gorda is an important tourist destination that suffered damage to ticket booth, bathroom and bar shaded area. While originally the scope of works included minor repairs, the needs have since expanded to a wider project.

### Status

The RDA met with the Ministry of Natural Resources and Labour to discuss the priority of projects. During this meeting it came to light the needs of the Virgin Gorda Baths were larger than originally expected in the Phase One plan. The RDA planning team has begun working with National Parks Trust to redefine the Statement of Requirement to capture the entire scope of the project.





# Special Debris Clearance

# Lead ministry: Health and Social Development

### Project: 108

### Status: Operations

Outcome 1: Improved tourism product that is aesthetically appealing, easily accessible and provides an enhanced experience to our visitors and a catalyst for economic recovery

### Overview

The hurricane disasters resulted in a significant amount of debris being deposited across the Virgin Islands and the project was developed to support the Department of Waste Management (DWM) to collect the debris. The objective of this project was to reduce the risk of damage and threat to human life, by removing debris which could become projectiles during strong winds ahead of the height of the 2018 hurricane season (early September).

#### Status

As of January, arrival of the crusher is still needed to finish the last portion of the debris clearance, which continues to be delayed. The vessel needed to clear the debris has had to return to its port of origin and while a new estimated time of arrival is being awaited, it is unlikely to arrive before mid-February.

# Removal of Derelict Boats

# Lead ministry: Natural Resources and Labour

### Project: 133

# Status: Planning

Outcome 1: Improved tourism product that is aesthetically appealing, easily accessible and provides an enhanced experience to our visitors and a catalyst for economic recovery

### Overview

The passing of hurricanes Irma and Maria in 2017 left a significant number of marine vessels stranded along the coastlines and bays of the Virgin Islands. The bulk of these vessels have been removed by the owners and their insurance providers. However approximately 280 derelict vessels remain that need to be removed from their land or sea location and then disposed of.

This is a large, complex project that requires detailed planning to minimize the effect on the environment and maintain value for money.

#### Status

Over the past month the planning team has conducted multiple site visits and held meetings with stakeholders to explore the most environmentally safe option, analyse access points, and scope staging sites.







# Elmore Stoutt High School

# Lead ministry: Education and Culture

# Project: 147

# Status: Planning

Outcome 2A: Restored educational and recreational facilities that provide a safe and secure environment for learning and recreational activities

#### Overview

The RDA is overseeing construction of temporary classrooms for Elmore Stoutt High School in consultations with the ministry and landowners. The outcome of the project is to improve the present conditions at the school.

### Status

Currently, the RDA is focusing and planning on immediate improvements to the building while discussing the number and location of temporary classrooms with MEC.

A TITL representative is visiting Tortola on 26 Feb 2019 to continue discussions on the location of the temporary classrooms. .



# AO Shirley Grounds Phase One

# Lead ministry: Education and Culture

#### Project: 152

# Status: Operations

Outcome 2A: Restored educational and recreational facilities that provide a safe and secure environment for learning and recreational activities

#### Overview

The AO Shirley athletics grounds is a priority project to renovate the grounds to meet international accreditation standards as a Level 2 ground, so that BVI can host upcoming national events later this year and future international events. This will require preparation of the grounds prior to the installation of the new track by the specialist company Mondo, repairs to make the perimeter secure to boost income-generation from events, installation of bathroom facilities, installation of lights to allow events after dark, repair to the spectator stand (ideally with shade), and renovation of the clubhouse pavilion to provide meetings, events and changing facilities.

#### Status

#### Track:


The track laying completed its first phase on January 31<sup>st</sup>. Next, the track will need to be painted.

#### Bathroom:

The bathroom scope of working is being finalized in order for an RFP (request for proposals) to be written and released to the public.

#### Fence and Gates:

A designer for the fence framework has been contracted and is currently creating fence using plastic recyclables. The temporary fencing has been procured, created, and put up in the work area.



# Virgin Gorda Police Barracks

# Lead ministry: Governor's Group

### Project: 182

# Status: Operations

Outcome 3B: Functioning law enforcement institutions and communication networks to restore a sense of safety and security and improved communications between agencies

### Overview

The purpose is to return the Virgin Gorda Police Barracks to a fully functional state with police able to deploy required numbers from Tortola. A key outcome will be for the police to be able to sleep personnel on Virgin Gorda to ensure a shift system can be effectively managed and to enable the pre-disposition of resources key to disaster preparedness ahead of the 2019 hurricane season.

#### Status

The RDA met with the project manager of the contract (Ridgeview Construction) and conducted a site inspection.

# Jost Van Dyke Admin Building

# Lead ministry: Governor's Group

### Project: 183

### Status: Operations

Outcome 3C: Immediate improvement to priority government infrastructure and systems to improve services key to easing ability of doing business and prepare for recovery

#### Overview

The repairs to the Jost Van Dyke administration building will re-establish a working space for the District Officer to coordinate public service delivery on the island, as well as space for the police, customs and immigration to become fully functional. This will re-establish a fully functioning border control point at the main jetty and re-establish a functional police base, including a cell. The full detailed scoping for this project has been completed and procurement has already commenced.

#### Status

Major works on the building have begun in January. On the 3 January the RDA met with stakeholders of the JVD admin building for a kick off meeting. Work has begun on scaffolding, windows, and damaged doors.
