The Board:

1. Approved:

- the minutes of the 55th Meeting as amended;
- the recommendation of award in favour of the firm OBM International for the provision of architectural and engineering design services for the Road Town Police Station at a cost of Forty-five Thousand and One US Dollars and Ninety-three Cents (US\$45,001.93);
- the recommendation of award on a Single Source basis in favour of the firm Crowe (BVI) Limited for the provision of payroll services to the RDA for the period 2022 2023 at a cost of Thirty-one Thousand, Two Hundred US Dollars (\$31,200.00);

- additional information before a decision is made on the contract extensions of GOVI Secondees for a further three (3) months while awaiting formal notification from GBVI on their request for extension. To be determined via Round Robin Resolution; and
- that the direct receipt of \$50,000 funding by the RDA from the BVI Tourism Board for the airport expansion project be discussed with the External Auditors.

- the risk 69 (Magistrates Court) remains RED;
- the risk 75 (RDA completing all projects) is a new risk that has been placed on the risk register and is classified as RED;
- the risk 76 FCDO Deed of Contributions has been reduced and is now classified as ORANGE;
- the risk 77 Delay in moving Magistrates Court. This risk is classified as RED;
- the risk 74 (Implementation Schedule) remains as an ISSUE;
- that the Executive Committee met on January 13, 2022 and reviewed and discussed decision papers and approved forwarding to the Board's 56th Meeting;
- that on January 19, 2022, the Audit & Risk Sub-Committee met and discussed the audit plans;

- that the approval of the Annual Internal Audit Plan was deferred until the requested refinements to the projects section are completed. This will allow the committee to petition the Board and management for additional resources to assist the Internal Auditor in effectively completing the plan;

- the Internal Audit status of the RDA's payroll function from inception to date; and
- the increased in contracted cash funding from \$58.4m to \$60.4m since the November Board meeting.
