- 1. Expected Outcome: The construction of a fit for purpose learning and working environment for the students and administrative staff of the Elmore Stoutt High School senior division.
- 2. **Summary of Scope**: The scope of this project includes the construction of three buildings, a Technical Block, a Classroom Block and an Administration Block. All three buildings will be connected via an access corridor running north/south. Therefore, the works have been broken up into four (4) packages as detailed below:

### • Work Package "A" - Building A – Technical Block:

Construction of a two-story reinforced concrete structure of approximately (20,430 sq. ft.) and the installation of fixtures, fittings, and related equipment (such as windows, doors, lighting, IT infrastructure, mechanical units, shop equipment and furnishings)

#### • Work Package "B" - Building B – Classroom Block North:

Construction of a three-story reinforced concrete structure of approximately (15,000 sq. ft.) and the installation of fixtures, fittings, and related equipment (such as windows, doors, lighting, IT infrastructure and furnishings)

#### • Work Package "C" - Building C – Classroom Block South:

Construction of a three-story reinforced concrete structure of approximately (18,000 sq. ft.) and the installation of fixtures, fittings, and related equipment (such as windows, doors, lighting, IT infrastructure and furnishings)
