 - ✓ A Motion was moved by RS and seconded by SA.
- Suggested that the name of the JVD School project be renamed to reflect the various functions that the end-user will utilise. This change will help with fundraising efforts and provide clarity to the community on what the project truly entails.
- Approved (with conditions)² the recommendation of award in favour of April Glasgow for the post of Community Liaison Officer (CLO) for a period of one year at a cost of Sixty Thousand US Dollars (US\$60,000.00) as well as the recommendation of award in favour of Ivy George for the post of Capacity Development Consultant to provide training support to the CLO for a period

of three months at a total cost of Six Thousand United States Dollars (US\$6,000.00).

- ✓ A Motion was moved by RS and seconded by SS.
- Approved the variations for additional works on government buildings as follows:
 - i. Vanterpool Administration Building: Two Hundred and Fifty-one Thousand, Two Hundred and Ninety-one US Dollars and Thirty cents (US\$251,291.30).
 - ii. Flax Administration Building: Forty-Five Thousand and Ninety-five US Dollars and Sixty-two Cents (US\$45,095.62).
 - Bregado Flax Educational Centre: One Hundred and Three Thousand, Five Hundred and Twenty-four US Dollars and Ninety Cents (US\$103,524.90) for payments already made (retroactive approval)
 - ✓ A Motion was moved by RS and seconded by SA.
